## SELECTION PROCESS

The Selection Process consists of marks obtained (out of 100) in the corresponding paper of **GATE 2024**, Group Discussion & Personal Interview.

Eligible candidates will have to appear for the **corresponding paper of GATE 2024**, i.e. **Electrical Engineering (EE) / Electronics and Communication (EC) / Civil Engineering (CE)/ Computer Science Engineering (CS)**.

Candidates qualified in corresponding paper of GATE 2024 shall only be eligible to be considered for the next stage of selection. Qualifying marks in GATE 2024 shall be as decided by GATE 2024 conducting authority.

Qualified candidates shall be short-listed category-wise for Group Discussion & Personal Interview based on their **normalized marks out of 100** in GATE 2024, in the corresponding paper.

Candidates shall have the option of appearing in the GD/Interview in Hindi or English.

Candidates shall obtain information about their status through their login at the POWERGRID Online Application System. Shortlisted candidates shall be able to download their interview call letter and other relevant documents through the candidate login.

Candidates shortlisted for the Group Discussion and Interview shall be required to bring the documents as mentioned in their interview call letter.
